"Workshop on improved risk management tools for organic inspectors" on 28.01.2014 and 29.01.2014 in Salzburg, Austria

Let's build a network between control authorities and bodies in the EU to support inspector's competence for risk-orientated inspections. The workshop takes place in the framework of the lifelong learning project IRM-ORGANIC www.irm-organic.eu

Aim of the workshop

The workshop shall support the competence and the knowledge exchange on risk oriented inspection approaches and on training concepts.

Background

Controls according to the EU-legislation (Reg. (EC) No. 834/2007 and implementing rules) on organic production shall assure consumer confidence into organic products in the member states of the European Union. The controls are implemented by control authorities or control bodies, accredited by an accreditation body according to EN 45011/ISO 17065 and approved and supervised by competent authorities. All control authorities and control bodies are required to conduct regular trainings for their inspectors according to the needs identified by regular performance reviews addressing the individual training needs of staff and inspectors.

In the innovation transfer project "Training on Improved Risk Management Tools for Organic Inspectors (IRM-ORGANIC)" the project partners developed a train-the-trainer concept for organic inspectors based on the results of a need analysis, current training concepts in the countries of the project partners and the training concepts in adjacent control and certification programs for food and feed.

Objective: Improvement of inspector's competence to conduct risk-oriented inspections

The aim of the project IRM-ORGANIC is to support control authorities and control bodies in Europe to mobilize their resources in a concerted way to optimize risk-oriented inspections and thus consumer protection and fair competition on the market for organic products.

IRM-ORGANIC conducted extensive research on the expectations of organic sector experts (operators, control sectors and users of organic certification) in different countries relating to

















risk-oriented inspections. An online survey for organic inspectors was carried out. Training concepts of control bodies in Austria, Germany, Italy and Poland were analysed and compared. The training in official food and feed control as well as in other private certification programs for food and feed was compared. Based on this, a proposal for a curriculum of a tailor-made train-the-trainer concept for risk-based inspections was developed within the project.

During the upcoming conference in Salzburg the project results will be presented and discussed. We would be very happy about your participation!

Who can participate?

We cordially invite control authorities and control bodies all over Europe, highly valued are experienced staff members involved in the inspector training process.

- Information on risk-oriented inspections: Project results of a need analysis based on expert interviews and data from an online survey for organic inspectors, current training concepts in Austria, Germany, Italy and Poland and the training concepts in adjacent private certification programs for food and feed.
- What does the future hold for organic controls? Discussion and information on the revision process of the EU-legislation on organic farming.
- Be part of the network: Building up a network among control bodies in Europe. Personnel communication e.g. in cases of irregularities or infringements makes working together much easier.
